





Securing the history center a home on Capitol Square was a major accomplishment for the Society. The 100,000-square-foot facility will more than double exhibition space of the current museum, welcome 200,000 guests annually and double the number of visiting students to 60,000, while also having the digital technology to virtually connect with residents across Wisconsin and beyond. Additionally, over the next three years, the Society's "museum without walls" initiative will bring history programming directly to communities like ours across Wisconsin's 72 counties.

Please continue your support of the History Center project. We look forward to being part of this exciting endeavor. The new History Center will be a hub for history that connects local history and community organizations across our state and will offer expanded resources and opportunities for our organization.

Request:

- This project will produce a master plan and design through construction of multiple building restorations, sitewide improvements and consideration of a new Visitor Center.
- WHS request \$5,829,400 GFSB to produce a site-wide master plan, program plan, and architectural and engineering design for the project.
- Although designing the entire project, this request is intended to complete Phase I of two phases in the 2023-2025 biennium. Phase II is proposed for the 2025-2027 biennium.

Background:

- Pendarvis showcases Cornish traditional stone construction techniques brought by immigrants who settled in Mineral Point to mine lead during the 1830s and 1840s.
- Pendarvis is also an early historic preservation effort, initiated by Bob Neal and Edgar Hellum in 1935.
- Pendarvis opened as a Wisconsin historic site on May 15, 1971.
- Pendarvis is composed of a collection of seven stone, stone-and-log, and log historic buildings and several ancillary structures on a 4.5-acre parcel that is dominated by a rocky bluff.
- Six of the Pendarvis Historic Site buildings are original to the site: Pendarvis House, Trelawny, Polperro, and the three connected houses that make up Tamblyn's Row (known as Martin Cabin, Middle Rowhouse, and East Rowhousel). All were constructed between 1840 and 1852, by and/or for Cornish immigrants.

Actions to Date:

- Feb '20: Architectural / Planning / Design Selection for Historic Structures Report
- Sep '21: Drainage Mitigation Analysis Report Finalized / Findings
- Nov '21: Historic Structure Report Finalized / Findings

Existing Conditions:

- Animal Infestations: Several buildings on the site show evidence of infestation by local wildlife, including foxes, groundhogs, raccoons, snakes, and mice. These infestations present both safety and health hazards to visitors and contribute to a general feeling of deterioration around the site.
- Topography: Site topography is extensive and presents quite a challenge to visitors at all levels of accessibility.
- Accessibility: The Pendarvis campus is nearly 100% physically inaccessible according to the standards of the Americans with Disabilities Act (ADA). Between master planning and design attempts will be made to provide accommodations, where possible.
- Pedestrian Walkways: How to move through Pendarvis as a pedestrian is not immediately apparent and is quite difficult for those unfamiliar with the site. A mixture of pathways and materials coupled with lack of signage and dramatic topography makes navigation through the site confusing.
- Vehicular Circulation and Parking: Vehicular circulation takes place on the one-way shared drive at the west end of the site. Parking is limited, however, and no clear stalls are denoted. There does not seem to be any "official" parking on-site.



- Drystack Walls, Stairs, and Pathways: The condition of the drystack retaining walls on the Pendarvis campus ranges from fair to poor. Settling, at a minimum, was noted on almost every wall on-site.
- Drainage and Utilities: Pendarvis has a history of water drainage issues. In September 2021 Vierbicher Associates completed the *Pendarvis Drainage Mitigation Analysis Report*. The document evaluated the site drainage conditions and provided options and potential costs for remediation. The report explored options to enhance site drainage and aid preservation efforts for the property.

Phase I construction improvements for the 2023-2025 biennium are proposed to the Shakerag, Rowhouse, and Welcome Center zones to include the following components:

- Conduct stormwater and groundwater management and mitigation in all Pendarvis work zones.
- Implement restoration, preservation, rehabilitation, and new work for Trelawny, Pendarvis House, Polperro, Workshop, and Visitor Center structures.
- Restore site and landscape and improve accessibility.
- Construct a new kitchen to hold a commercial kitchen to support Pendarvis House.
- Construct a new visitor center or rehabilitate and repurpose the existing visitor center.
- Relocate staff offices, welcome activities, and guest services as necessary to meet programming and construction objectives.


