

Step-by-Step Guide Forming a Local Historical Organization in Wisconsin

- 1 Adopt By-Laws: See the sample bylaws at https://www.wisconsinhistory.org/pdfs/localhist/WHS-4919bylaws.pdf
- 2 Apply for Affiliation: Application forms are online at https://www.wisconsinhistory.org/Records/Article/CS4042
 - To submit your application, contact your Field Services Representative:

- 3 Incorporate: Following approval by the Wisconsin Historical Society Board of Curators, in consultation with applicant, Society staff will file Articles of Incorporation with Department of Financial Institutions.

NOTE: Since the Board meets irregularly, you may choose to incorporate before you affiliate with the Society. To incorporate, file DFI Form 102 with the Department of Financial Institutions at https://www.wdfi.org/ resources/indexed/site/corporations/dfi-corp-102.pdf

- 4 Apply for a Federal Employer ID Number (FEIN): The FEIN is a nine-digit number assigned to corporations, nonprofit organizations, and other entities for tax filing, reporting purposes, and establishing your business tax account.
 - You will use the SS-4 form to apply for the FEIN. This can be done online at www.irs.gov/businesses/small/article/0,,id=102767,00.html

- 5 Open a Bank Account and Establish Check Signing Procedures

- 7 Register as a Charitable Organization (if necessary): Register through the Wisconsin Department of Safety and Business Services. To fill out Charitable Organization Registration Statement Form 296, go to <u>https://www.wdfi.org/CharitableOrganizations/forms/dfi-dccs-296.pdf</u>
- 8 Apply For Wisconsin Sales and Use Tax Certificate of Exempt Status
